RECRUITMENT OF MEMBER TRUSTEE

The Winnipeg Civic Employees' Pension Plan is governed under a jointly-trusteed structure according to the terms and conditions of the Pension Trust Agreement entered into by the City of Winnipeg and the Signatory Unions. The 14-member Board of Trustees of The Winnipeg Civic Employees' Benefits Program (Pension Fund) is appointed equally by the City of Winnipeg and the Signatory Unions. Of the seven Member Trustees (appointed by Signatory Unions), one Member Trustee is appointed on behalf of the Plan's pensioners, survivor beneficiaries and deferred members (collectively referred to here as Retirees).

NOTICE OF UPCOMING EXPIRATION OF TERM

Rick Borland has served on The Board of Trustees of The Winnipeg Civic Employees' Benefits Program (Pension Fund) as the Member Trustee on behalf of Retirees, since January 1, 2007. Mr. Borland's current term of office will expire on December 31, 2018. He will not be seeking re-appointment for the upcoming term, beginning January 1, 2019.

APPLICATION PROCESS

Any Retiree who wishes to be considered for appointment to The Board of Trustees of The Winnipeg Civic Employees' Benefits Program (Pension Fund), for a four-year term beginning January 1, 2019, must submit an application to the Board indicating his or her wish to be appointed as the Member Trustee, on behalf of Retirees, and setting out his or her qualifications for such office.

To be considered effective, an application must contain the written endorsement (including printed name and signature) of 50 other Retirees of The Winnipeg Civic Employees' Pension Plan.

Please note that the following are not eligible to be a Trustee according to the Pension Trust Agreement:

• a person who is less than 18 years of age;

- a person who has the status of a bankrupt;
- a person who has been determined to be mentally incompetent in accordance with the requirements of applicable legislation;
- a person who is not bondable.

Any Retiree who submits an application must participate in an interview and selection process established by the Signatory Unions.

The deadline for receipt of applications by the Board is **October 29, 2018**, at the following address:

The appointment of the Member Trustee on behalf of Retirees will be made by a majority of the Signatory Unions.
